3. Planning Itinerary (Wendy, Deena, Peri)

Due to time constraints, the committee agreed to address this agenda item at their next meeting. Tabled in brief was the intention to collate whakapapa and information to ideally construct into a book or similar, for all whanau was raised, and this could be a smaller project in conjunction with the reunion.

4. Financial Update (Peri)

The first Panui distributed to whanau has already established the registration fees, options on payment as well as a payment/saving system over 30 weeks. The fees shall remain according to the Panui ie: Adults (16yrs+) @ \$20 per day; Young Adults (7-15yrs) \$10 per day; Children (0-6yrs) Free. These amounts are for the 3 day duration of the reunion. The committee requires half of your registration fee paid by 30th June 2007, with the remainder paid by 29th November 2007. The last day to register to this reunion is 29th November 2007.

The committee agreed that those children (and their partners) of Peri & Pareheuea Te Wao, who have indicated they will be attending, will be free of charge.
